- Work commenced on set up of the Assessor's & Zoning Administrator's office on December 26th and is fairly well set up now.
- Acting ZA Johnson turned over the files and access to the ZAs Google account on Jan 1, 2025.
- Work continues on organizing and filing paper applications, complaints, and permits. All are being moved from yearly binders to a file system by parcel ID# for easy checking the history of any ZC and CUP permits have been issued.
- Performed massive clean out and organization of both the ZA's google mail and documents account.
- December 18th hearings for Oberdorf and Tracy STR CUPs were both approved. Hearing for Seaberg Resort resulted in application being rejected due to more than one principal use was being requested.
- There is currently one CUP application awaiting scheduling for hearing for Seaberg STR on the newly purchased property (former Cross residence). It is expected to be scheduled at the January 16, 2025 meeting of the PC.
- Training I completed my MSUE Citizen Planner training in November. This class offers a certificate rating of "Master" Citizen Planner if one would like to pursue. I understand that this class is a prerequisite to the Zoning Administrator's course and upon successful completion of that, one automatically gets a rating of "Master Citizen Planner." I decided to complete the required tasks to certify now. First task of taking the 40 question quiz is complete. The second requirement is to do a "keystone presentation" which I will complete on January 23, 2025 at the Organizational Meeting of the ZBA. The topic of this presentation will be Variances. My MSUE ZA training commences on Jan 30th. There are three on-line sessions followed by two days of inperson training Feb 20, 21 in Mt. Pleasant.
